#### If inhaled

### 4.3 Indication of immediate medical attention and special treatment needed, if necessary

Basic Treatment: Establish a patent airway (oropharyngeal or nasopharyngeal airway, if needed). Suction if necessary. Encourage patient to take deep breaths. Watch for signs of respiratory insufficiency and assist ventilations if necessary. Administer oxygen by nonrebreather mask at 10 to 15 L/min. Monitor for pulmonary edema and treat if necessary . Monitor for shock and treat if necessary . Anticipate seizures and treat if necessary . For eye contamination, flush eyes immediately with water. Irrigate each eye continuously with 0.9% saline (NS) during transport . Do not use emetics. For ingestion, rinse mouth and administer 5 ml/kg up to 200 ml of water for dilution if the patient can swallow, has a strong gag reflex, and does not drool . Irritating materials

## SECTION 12: Ecological information

### 12.1 Toxicity

- Toxicity to fish: LC50 - *Oncorhynchus mykiss* (previous name: *Salmo gairdneri*) - > 0.4 mg/L - 96 h.
- Toxicity to daphnia and other aquatic invertebrates: EC50 - *Daphnia magna* - 1 700 mg/L - 48 h.
- Toxicity to algae: EL50 - *Desmodesmus subspicatus* (previous name: *Scenedesmus subspicatus*) - > 10 mg/L - 96 h.
- Toxicity to microorganisms: EC0 - *Pseudomonas putida* - > 10 000 mg/L - 30 min.

### 12.2 Persistence and degradability

AEROBIC: Using the Warburg test which employs activated sludge, 1-octadecanol gave a theoretical oxygen demand of 0.3, 0.5, and 0.3 percent in 6, 12, and 24 hours(1). However, using an acclimated mixed shake flask culture with incremental substrate addition of 1-octadecanol, biomass yield reached 54.5 percent after seven days(2). Given sufficient time in contact with adapted microbial species under conditions otherwise non-limiting, the complete disappearance of 1-octadecanol as identifiable molecular species will occur(2).

### 12.3 Bioaccumulative potential

An estimated BCF value of  $2.8 \times 10^4$  was calculated for 1-octadecanol(SRC), using an experimental water solubility of  $1.1 \times 10^{-3}$  mg/L at 25 deg C(1) and a recommended regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is very high(SRC), provided the compound is not metabolized by the organism(SRC).

### 12.4 Mobility in soil

The Koc of 1-octadecanol is estimated as  $1.8 \times 10^5$ (SRC), using a water solubility of  $1.1 \times 10^{-3}$  mg/L at 25 deg C(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that 1-octadecanol is immobile in soil(SRC).

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
