## SECTION 4: First-aid measures

### 4.1 Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### 4.3 Indication of immediate medical attention and special treatment needed, if necessary

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

## **6.1 Personal precautions, protective equipment and emergency procedures**

### 12.1 Toxicity

### 12.2 Persistence and degradability

AEROBIC: Gemfibrozil was 69% removed during passage through a municipal sewage treatment plant located near Frankfurt am Main, Germany, over six days; however, removal could also be attributed to adsorption to sludge(1).

### 12.3 Bioaccumulative potential

An estimated BCF of 3 was calculated in fish for gemfibrozil(SRC), using an estimated log Kow of 4.8(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### 12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of gemfibrozil can be estimated to be 430(SRC). According to a classification scheme(2), this estimated Koc value suggests that gemfibrozil is expected to have moderate mobility in soil. The pKa of gemfibrozil is estimated as 4.5(3), indicating that this compound will exist almost entirely in the anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(4).

## SECTION 13: Disposal considerations

### 13.1 Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
