SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

4.3 Indication of immediate medical attention and special treatment needed, if necessary

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

Accidental Release Measures. Personal precautions: Wear respiratory protection. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Evacuate personnel to safe areas. Environmental precautions: Prevent further leakage or spillage if safe to do so. Do

not let product enter drains. Discharge into the environment must be avoided. Methods and materials for containment and cleaning up: Soak up with inert absorbent material and dispose of as hazardous waste. Keep in suitable, closed containers for disposal.

- Toxicity to fish: LC50; Species: *Lepomis macrochirus* (Bluegill) weight 0.58 g; Conditions: freshwater, flow through; Concentration: 300 ug/L for 96 hr (95% confidence interval: 240-320 ug/L) /14.17% purity

12.2 Persistence and degradability

AEROBIC: Utilizing a CO₂ evolution test with a freshly prepared activated sludge inoculum, methylisothiazolinone reached 54.1, 55.8 and 47.6% CO₂ evolution, at initial concentrations of 0.3, 0.03 and 0.01 ppm, respectively, over a 28 day incubation period; the results classified the compound as inherently biodegradable and demonstrated a dependence on concentration. Microcosm studies in aerobic water found degradation of methylisothiazolinone to be primarily due to biodegradation based on tests using sterile controls. The half-life of methylisothiazolinone in an aerobic microcosm using river water and sediment was 9 days(1).

12.3 Bioaccumulative potential

A BCF of 3 was reported in bluegill sunfish (*Lepomis macrochirus*) for methylisothiazolinone(1). According to a classification scheme(2), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of methylisothiazolinone can be estimated to be 12(SRC). According to a classification scheme(2), this estimated Koc value suggests that methylisothiazolinone is expected to have very high mobility in soil.

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and

then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
