4.1 Description of necessary first-aid measures

If inhaled

12.2 Persistence and degradability

In 28-day incubation studies using a vegetable-growing clay loam soil, degradation of iprodione was >50% in non-sterile and <20% in sterile (autoclaved) soil(1); the results suggest that microbes were responsible for the primary disappearance in the soil(1). Similar results were found in another study in which degradation was much slower in soils treated with sodium azide, gamma irradiation, chloramphenicol or cycloheximide as compared to non-sterile soil(2).

12.3 Bioaccumulative potential

An estimated BCF of 41 was calculated for iprodione(SRC), using a log Kow of 3.00(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration is moderate. Under basic conditions, the high rate of hydrolysis(4) for iprodione will decrease the potential for bioconcentration.

12.4 Mobility in soil

The Koc for iprodione is 700(1). According to a classification scheme(2), this Koc value suggests that iprodione is expected to have low mobility in soil. In one study, an investigation of the leachability of pesticides applied to a golf course was conducted using lysimeters at actual golf courses(3). At a fairway consisting of Korean lawn grass grown over volcanic ash soil, iprodione was applied at 1.5 g/l/sq m. Leachate was collected 40 cm

below the surface and analyzed over a 37 day period. At the end of 37 days, a total of 0.2% of the applied iprodione had leached through the fairway soil profile(3).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
