SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

4.3 Indication of immediate medical attention and special treatment needed, if necessary

There are no antidotes for ifosfamide or its metabolites. Dialysis may be considered in view of the favorable toxicokinetics (low apparent volume of distribution), but no studies are yet available to confirm this.

Use dry chemical, carbon dioxide or alcohol-resistant foam.

Wear self-contained breathing apparatus for firefighting if necessary.

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

6.2 Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

6.3 Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

7.1 Precautions for safe handling

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Intact vials of ifosfamide should be stored at room temp. Ifosfamide may liquefy at temperatures above 35 deg C.

Ensure adequate ventilation. Handle in accordance with good industrial hygiene and safety practice. Set up emergency exits and the risk-elimination area.

Wear tightly fitting safety goggles with side-shields conforming to EN 166(EU) or NIOSH (US).

Skin protection

Wear fire/flammable resistant and impervious clothing. Handle with gloves. Gloves must be inspected prior to use. Wash and dry hands. The selected protective gloves have to satisfy the specifications of EU Directive 89/686/EEC and the standard EN 374 derived from it.

The constituted soln is stated to be chemically & physically stable for 7 days at 30 deg C & for 3-6 wk under refrigeration. Because of microbiological concerns, the manufacturer recommends storage under refrigeration & use in 6 hr for ifosfamide not constituted with bacteriostatic water for injection.

12.2 Persistence and degradability

AEROBIC: Ifosfamide has been shown to be non-biodegradable in laboratory-scale sewage treatment studies(1). Ifosfamide, present at 160 mg/l, was not biodegraded in four weeks using a sludge inoculum at 200 mg/l and a modified Zahn-Wellns test nor, present at 11.4 mg/l, in 8 weeks using a test simulating continuous biological sewage treatment(2).

Concentrations measured in a German hospital effluent, STP influent and STP effluent indicated that no adsorption, biodegradation or other degradation processes took place(2).

12.3 Bioaccumulative potential

An estimated BCF of 3 was calculated for ifosfamide(SRC), using a log Kow of 0.86(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

The Koc of ifosfamide is estimated as 70(SRC), using a log Kow of 0.86(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that ifosfamide is expected to have high mobility in soil.

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
