Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Rinse with pure water for at least 15 minutes. Consult a doctor.

### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### Minimum/Potential Fatal Human Dose

There have been reports of death after overdoses with citalopram alone, at doses of 2800 mg and 3920 mg, with no co-ingested substances. However, patients have survived overdoses of up to 6000 mg. Salt not specified

### Absorption, Distribution and Excretion

GI absorption is about 100%; time to reach peak plasma concn is 2-4 hr; absolute bioavailability is about 100%; oral clearance after a single or multiple dose is 26 L/hr; protein binding is 50%; volume of distribution is 14 L/kg; half-life following a single dose is 33 hr; urinary excretion is 12% of an oral dose. /from table/ Salt not specified

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **6.3 Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
