#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### **4.3 Indication of immediate medical attention and special treatment needed, if necessary**

#### **Absorption, Distribution and Excretion**

A microspectrofluorometric technique was used to study the penetration & localization of psoralen, 4,5'8-trimethylpsoralen & 4'-aminomethyltrioxsalen in single living l-cells. the concn of compounds inside the cell reached a plateau in 2 minutes with psoralen & aminomethyltrioxsalen & in 20 min with trioxsalen. washing of the cells with culture medium produced only a partial removal of the 3 furocoumarins, distributed in equivalent amt in the nucleus and cytoplasm. the study indicated that when psoralens penetrate into the cells photodamage is possible at the nucleus level as well as the cytoplasm.
