#### If inhaled

### 12.2 Persistence and degradability

2-Chloroethyl ethyl sulfide and its hydrolysate, ethyl 2-hydroxyethyl sulfide, may undergo reductive cleavage of the sulfide bond to yield thiols which are further susceptible to biodegradation under both aerobic and anaerobic conditions(1).

### 12.3 Bioaccumulative potential

An estimated BCF of 9 was calculated for 2-chloroethyl ethyl sulfide(SRC), using an estimated log Kow of 2.16(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low. 2-Chloroethyl ethyl sulfide hydrolyzes faster in pure water than it dissolves(4); based upon measured hydrolysis rates in ethanol-water and acetone-water systems, the extrapolated hydrolysis half-life in pure water at 25 deg C is about 44 sec(4). Therefore, bioconcentration in aquatic organisms is not an important environmental fate process(SRC).

### 12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for 2-chloroethyl ethyl sulfide can be estimated to be 149(SRC). According to a classification scheme(2), this estimated Koc value suggests that 2-chloroethyl ethyl sulfide is expected to have high mobility in soil. However, before 2-chloroethyl ethyl sulfide can leach from soil, it will be hydrolyzed. A study indicates that 2-chloroethyl ethyl sulfide hydrolyzes faster in pure water than it dissolves(3); based upon measured hydrolysis rates in ethanol-water and acetone-water systems, the extrapolated hydrolysis half-life in pure water at 25 deg C is about 44 sec(3).

### 13.1 Disposal methods

**Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

**Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
