## SECTION 4: First-aid measures

### 4.1 Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

**SECTION 12: Ecological information****12.1 Toxicity**

- Toxicity to fish: LC50 - *Cyprinus carpio* - > 0.03 mg/L - 96 h.
- Toxicity to daphnia and other aquatic invertebrates: EC50 - *Daphnia magna* - > 0.03 mg/L - 48 h.
- Toxicity to algae: EC50 - *Pseudokirchneriella subcapitata* (previous names: *Raphidocelis subcapitata*, *Selenastrum capricornutum*) - > 0.055 mg/L - 96 h.
- Toxicity to microorganisms: EC50 - activated sludge of a predominantly domestic sewage - > 1 000 mg/L - 3 h. Remarks: Respiration rate.

**12.2 Persistence and degradability**

Biological treatment of gray water containing an influent average avobenzone concentration of 3.5 ug/L reduced the average concentration to 0.48 ug/L under aerobic treatment, 1.27 ug/L under anaerobic treatment, and 0.2 ug/L with combined aerobic and anaerobic treatment(1).

**12.3 Bioaccumulative potential**

An estimated BCF of 113 was calculated for avobenzone in fish(SRC), using an estimated log Kow of 4.51(1) and a regression-derived equation(1). According to a classification scheme(2), this BCF suggests the potential for bioconcentration in aquatic organisms is high(SRC), provided the compound is not metabolized by the organism(SRC).

**12.4 Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc of avobenzone can be estimated to be 1980(SRC). According to a classification scheme(2), this estimated Koc value suggests that avobenzone is expected to have low mobility in soil.

## 13.1 Disposal methods

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
