### **5.2 Specific hazards arising from the chemical**

Excerpt from ERG Guide 128 [Flammable Liquids (Water-Immiscible)]: HIGHLY FLAMMABLE: Will be easily ignited by heat, sparks or flames. Vapors may form explosive mixtures with air. Vapors may travel to source of ignition and flash back. Most vapors are heavier than air. They will spread along ground and collect in low or confined areas (sewers, basements, tanks). Vapor explosion hazard indoors, outdoors or in sewers. Those substances designated with a (P) may polymerize explosively when heated or involved in a fire. Runoff to sewer may create fire or explosion hazard. Containers may explode when heated. Many liquids are lighter than water. Substance may be transported hot. For hybrid vehicles, ERG Guide 147 (lithium ion batteries) or ERG Guide 138 (sodium batteries) should also be consulted. If molten aluminum is involved, refer to ERG Guide 169. (ERG, 2016)

### **5.3 Special protective actions for fire-fighters**

Use powder, alcohol-resistant foam, water spray, carbon dioxide. In case of fire: keep drums, etc., cool by spraying with water.

## 12.2 Persistence and degradability

In a study of the degradation of hydrocarbons by various yeast cultures, 1-decene was assimilated by two out of thirteen cultures studied, *Candida lipolytica* and *Candida pulcherrima*(1). In a similar study of the yeast species *Candida*, 1-decene was found to be assimilated by 15 out of 55 *Candida* yeast cultures with only 2 of these displaying abundant growth, 8 moderate growth, and 5 slight growth(2). 1-Decene's linear hydrocarbon structure would suggest that biodegradation is an important process in soil and water(3).

## 12.3 Bioaccumulative potential

An estimated BCF of 488 was calculated for 1-decene(SRC), using a log Kow of 5.70(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high.

## 12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for 1-decene can be estimated to be about 1720(SRC). According to a classification scheme(2), this estimated Koc value suggests that 1-decene is expected to have low mobility in soil.

## 13.1 Disposal methods

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
