If inhaled

Fresh air, rest. Refer for medical attention.

SYMPTOMS: Symptoms of exposure to this compound may include skin, eye and upper respiratory tract irritation. ACUTE/CHRONIC HAZARDS: This compound may cause skin, eye and respiratory tract irritation. When heated to decomposition it emits toxic fumes. (NTP, 1992)

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
