## SECTION 4: First-aid measures

### 4.1 Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### 4.2 Most important symptoms/effects, acute and delayed

**SYMPTOMS:** Symptoms of exposure to this compound include skin irritation. It can cause eye irritation. It can also cause skin sensitization (allergic reactions), lacrimation, depression, reproductive effects, liver effects, kidney effects and thyroid effects. Dermatitis may also occur. **ACUTE/CHRONIC HAZARDS:** This compound may cause irritation of the skin and eyes. When heated to decomposition it emits toxic fumes of carbon monoxide, carbon dioxide and nitrogen oxides. It may cause lacrimation. (NTP, 1992)

### 4.3 Indication of immediate medical attention and special treatment needed, if necessary

#### Minimum/Potential Fatal Human Dose

3= moderately toxic: probable oral lethal dose (human) 0.5-5 g/kg; between 1 oz & 1 pint (or 1 lb) for 70 kg person (150 lb).

#### Absorption, Distribution and Excretion

Feeding trial in cows was conducted to determine whether ethoxyquin or its residues are transferred from feed to milk when added to cow feed at 0.015% of dry matter intake. less than 7 ug ethoxyquin/l was detected in milk by fluorimetry & by thin-layer chromatography.

# **SECTION 6: Accidental release measures**

## **6.1 Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

## **6.2 Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

## **6.3 Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

## **7.1 Precautions for safe handling**

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Store the container tightly closed in a dry, cool and well-ventilated place. Store apart from foodstuff containers or incompatible materials.
